(D) ***Transportation.***

Those requiring transport facility by College bus have to fill up the form and remit the fee for six months. Transport facility will be available from Vyttila, Thripunithura (Seaport Airport road), Thoppumpady, Valanjambalam, GCDA, Palarivattom, Highcourt Junction, Vaduthala, Perumbavoor, Paravur, Kodungallur Thrissur and Irinjalakuda to College and back.
